Liability Waiver I Cancellation Policy:

I fully understand that there are hazards and dangers associated with and incidental to SCUBA diving activities, and that I must employ proper principles of diving safety in order to dive at a Diving for Life event. I understand that the nearest available recompression chamber may not be located on the island and may require air evacuation for use, and may not always be immediately available for use. I fully understand that the time involved with boat and/or air transportation poses additional risk to my personal safety. I hereby assume all such risks, danger and costs attendant to SCUBA diving activities at and during this event. By signing this waiver of liability, I agree to release Diving for Life, Inc., its officers, board members and volunteers, from any claim or cause of action I or my estate, personal representatives, heirs, executors and assigns may have for personal injury, illness, property damage, wrongful death or economic loss arising from transportation to, from, in and near Roatan, including car, air or boat transportation used for any reason or arising from my snorkel or diving activities or other activities I engage in during this event, whether caused by the negligence of Diving for Life, Inc., or otherwise.

Full payment of Balance is due by **June 15, 2010**. Deposits and any payments are refundable, **less a \$300 per person cancellation fee**, until June 15, 2010. After that date, refunds can be made only if DFL is sold out and your place can be resold. All cancellations must be sent in writing to DFL. (**NOTE:** I understand that \$300 of my deposit is not refundable under any circumstances.) Tax deduction letters will be addressed to the registrant or the person who paid the full registration fee. Diving for Life, Inc. recommends participants invest in trip cancellation and dive insurance.
